In Canton, only stakeholders to a transaction see, validate and record their parts of a transaction, even when it spans multiple applications.



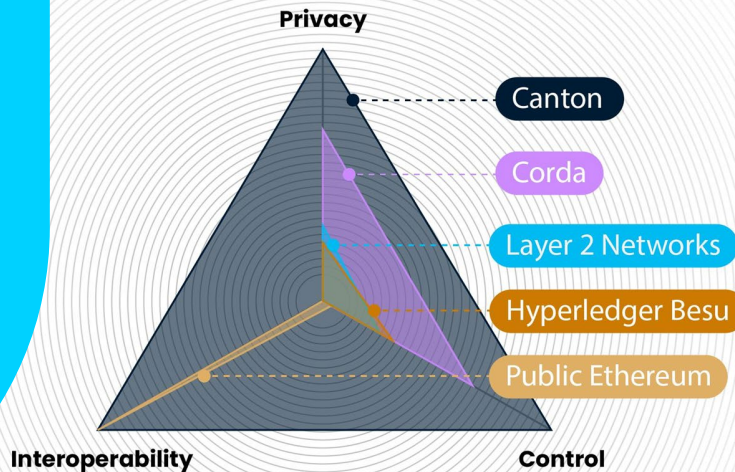
Independent control

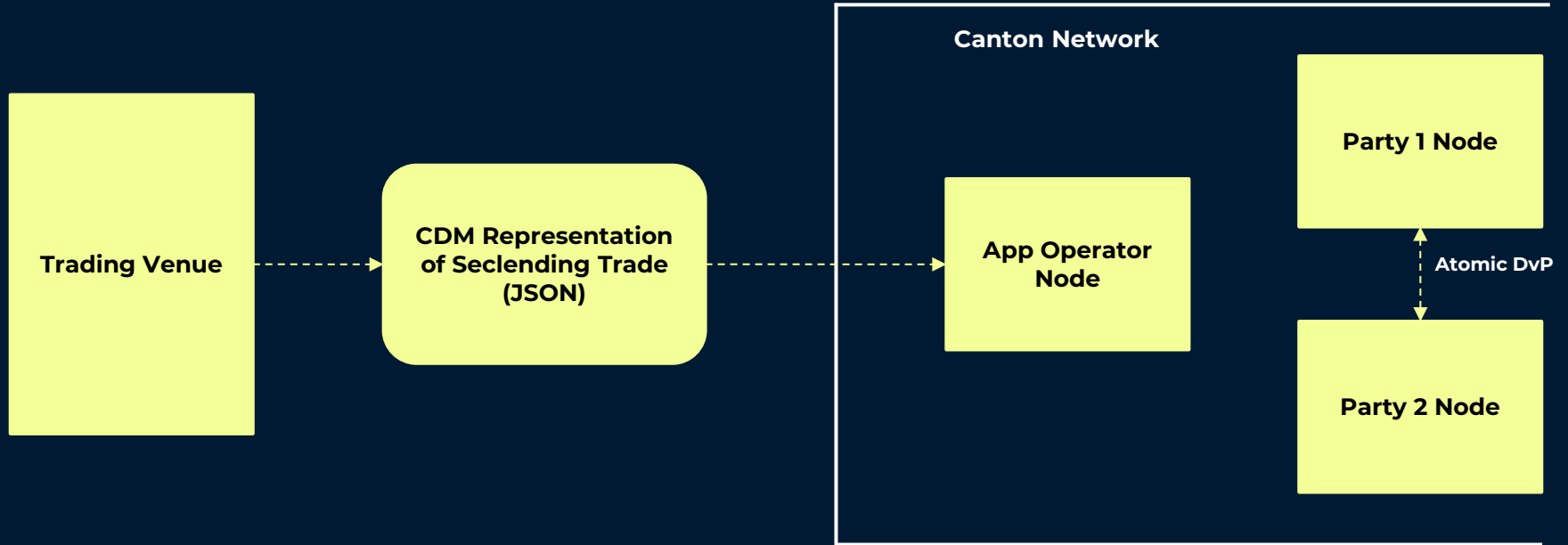

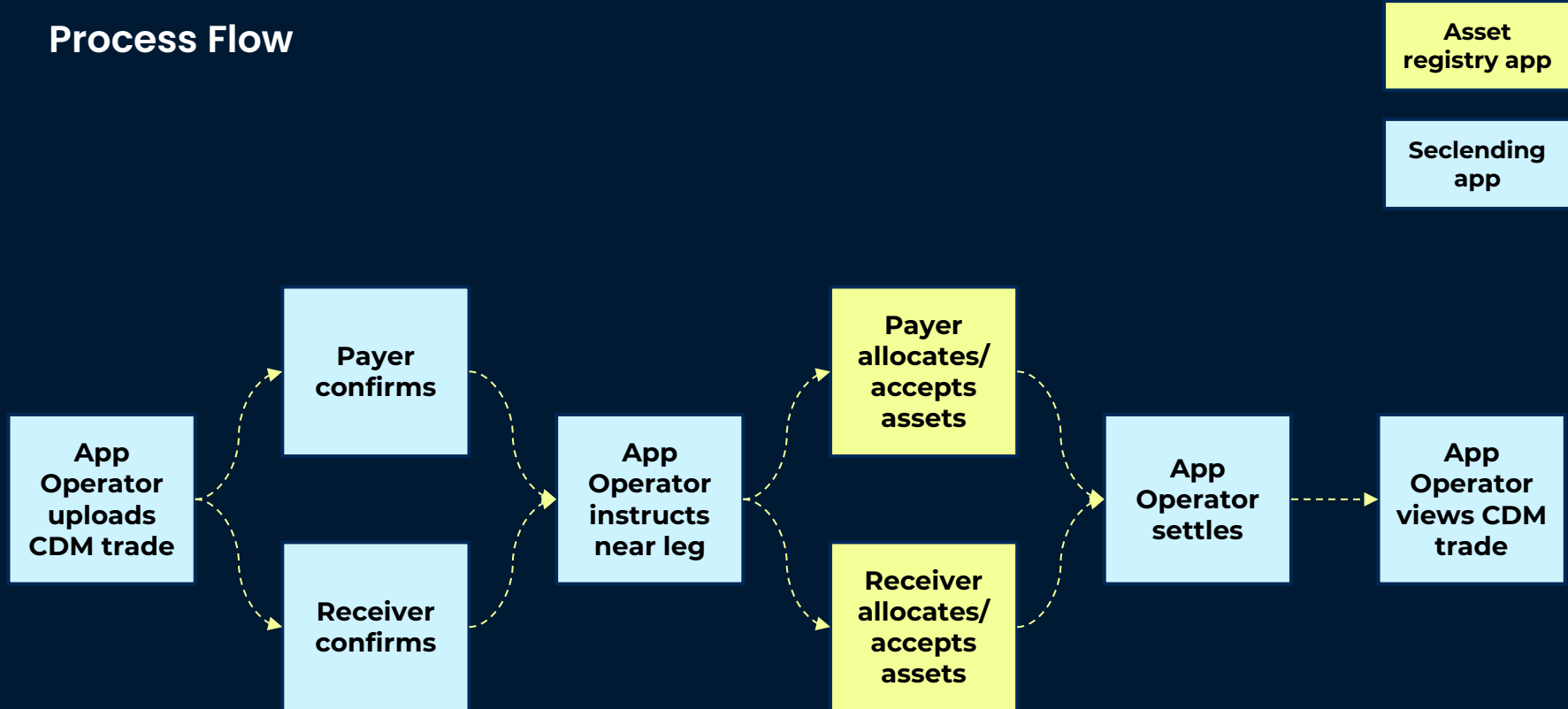
